Williamson College of the Trades – SUMMER TRADE CAMPS – JULY 2025

Williamson College of the Trades is providing a 4-day, hands-on, comprehensive trade camps in July of 2025. The camp provides hands-on seminars in the various trade programs offered at Williamson, culminating in a collaborative construction project experience. The trade programs include Carpentry, Electrical, Landscape Construction Management, Machine Tool Technology, Masonry, and Power Plant Technology. This camp is designed for young men who will be graduating high school in the spring/summer of 2026 (current **rising high school seniors**) with aspirations or interest in attending Williamson. The camp is a residential program with participants staying in a college dormitory room, dining on campus, and participating in fun evening recreational activities. There are **no costs or fees** for participants to attend the camp. No previous experience in construction-related fields is required, just an interest in exploring the trades. **Please note that submitting this form does not guarantee a spot in one of the trade camps, as we have limited space for participants.**

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING. THIS IS A LEGALLY BINDING DOCUMENT BETWEEN THE PARENT/GUARDIAN (I) AND WILLIAMSON COLLEGE OF THE TRADES. THIS SIGNED FORM MUST BE SUBMITTED BY A PARENT OR LEGAL GUARDIAN BEFORE ANY CHILD IS ALLOWED TO PARTICIPATE IN CAMP.

I, the undersigned, wish for my Child (hereafter "Child") to participate in Williamson's Summer Trade Camp (hereafter "Camp") on the date(s) and location indicated above and, in consideration for my Child's participation, I hereby agree as follows:

I acknowledge, understand and appreciate that as part of my Child's participation in the Camp there are dangers, hazards and inherent risks to which my Child may be exposed, including the risk of serious physical injury, temporary or permanent disability, and death, as well as economic and property loss. I further realize that participating in the Camp may involve risks and dangers, both known and unknown, and have elected to allow my Child to take part in the Camp.

I, on behalf of my Child, hereby understand and acknowledge that my failure to disclose relevant information may result in harm to my child and/or others during this Camp. By signing my name, I represent and warrant that my child's mental, physical or medical condition enables him/her to participate in the Camp without any special accommodation.

I, on behalf of my Child, hereby release Williamson College of the Trades, its Board of Trustees, Administration, Faculty, Staff, and all other officers, directors, employees and agents from any and all liability as to any right of action that may accrue to my heirs or representatives for any injury to my Child or loss that my Child may suffer while training, preparing, participating and/or traveling to or from the Camp. This agreement is binding on my heirs and assigns.

I, on behalf of my Child, furthermore release, indemnify and hold harmless Williamson College of the Trades from and against any and all liability, actions, debts, claims and demands of every kind whatsoever, specifically including, but not limited to, any claim for negligence or negligent acts or omissions and any present or future claim, loss or liability for injury to person or property that my Child may suffer, for which my Child may be liable to any other person, that may or does arise out of my Child's participation in the Camp. I understand that Williamson College of the Trades accepts no responsibility for my Child's personal property.

I, on behalf of my Child, furthermore acknowledge that Williamson College of the Trades does not provide on-site medical care or provide and administer any prescription or over-the-counter drugs and in the event of an accident or serious illness, I hereby authorize representatives of the Camp to obtain emergency medical treatment for my Child on my behalf. I hereby hold harmless and agree to indemnify from any claims, causes of action, damages and/or liabilities, arising out of or resulting from said medical treatment. I further agree to accept full responsibility for all expenses, including medical expenses that may derive from any injuries to my Child that may occur during his/her participation in the Camp.

By my signature below I, on behalf of my Child agree to give the Camp permission to use the electronic image of my Child on Williamson College of the Trades' website or in publications and I agree to indemnify and hold harmless Williamson College of the Trades, its Board of Trustees, Administration, Faculty, Staff, Student Leaders, Camp Staff, and all other officers, directors, employees and agents from any and all liability as to any right of action that may accrue to my heirs and assigns as a result of Williamson College of the Trades using my Child's image.

This RELEASE shall be governed by and construed under the laws of Pennsylvania. This RELEASE contains the entire agreement between the parties to this agreement and the terms of this RELEASE are contractual and not a mere recital. The information I have provided is disclosed accurately and truthfully. I have been given ample opportunity to read this document and I understand and agree to all of its terms and conditions. I understand that I am giving up substantial rights (including my right to sue), and acknowledge that I am signing this document freely and voluntarily, and intend by my signature to provide a complete and unconditional release of all liability to the greatest extent allowed by law. My signature on this document is intended to bind not only myself and my Child but also the successors, heirs, representatives, administrators, and assigns of my Child and myself.
